

DeDe's Backyard BBQ OFFICIAL CONTEST RULES

1. How to Enter the Promotion:

- These rules govern the DeDe's Backyard BBQ promotion being conducted by K104-FM beginning on Friday, June 07, 2019 and ending on Saturday, July 27, 2019.
- To participate in the Promotion, entrants must visit the Station website at www.myk104.com and visit the Promotion's official entry page where they must complete and submit their entry. Entry forms must include your first and last name, complete address, city, state, and zip code, telephone number, date of birth and their valid email address.

All entries submitted become the sole property of the Station and will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. Stations' computer is the official time keeping device for the Promotion.

All entries must be received by 11:59pm (CST) on Friday, July 26, 2019. The Station is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches.

2. Disclaimer:

- Must be 21 years of age or older to attend the event. Must have valid ID to enter.
- Ticket cannot be duplicated. This ticket is non-transferable and non-refundable and cannot be redeemed for cash.
- Ticket does not guarantee admission. K104-FM Service Broadcasting reserves the right to deny entry to any individual. First come, first serve.
- No outside Food or Drinks. No Tailgating. No Firearms. No Drugs.
- Free food for first 700 attendees.
- K104-FM Service Broadcasting and Eberstein Witherite, LLP is not responsible for lost or stolen items and shall be completely held harmless against any and all liability, loss of life and/or property, damage or expense, including, without

limitation, attorney's fees and cost of litigation, resulting from any and all swimming pool accidents or incidents occurring at DeDe's Backyard BBQ.

- Holder assumes all risks occurring before, during or after the event, including injury by any cause, and releases management, facility, participants, K104-FM Service Broadcasting, Eberstein Witherite, and KDC LLC. Their representatives and personnel, and their respective affiliates from any related claims.

2. Eligibility Restrictions:

- The Promotion is open to all persons who are 21 years of age or older and who reside in the immediate 12 counties in the Dallas/Fort Worth metropolitan area. Employees of the Station, its licensee, the licensee's parent, subsidiary and affiliated entities, the members of their immediate families (spouse, parent, sibling or child) and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable Federal, state and local laws and regulations and is void where prohibited.

- Listeners are eligible to win a prize in a promotion conducted by the Station only once every sixty (60) days. Only one (1) winner per household is permitted in any Station promotion.

- Winners will be required to sign a liability/publicity release, show a valid government- issued photo identification card, and social security card to claim prize.

- Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements. The Station will also delete any entry knowingly received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

- By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

- The Station, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of the Station's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
