

HOME SCHOOL HOOK UP OFFICIAL CONTEST RULES

1. How to Enter the Promotion:

Entry forms must include your first and last name, complete address, city, state, and zip code, telephone number, date of birth and their valid email address. The Station is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties and other technological problems. One randomly selected winners will be announced Monday-Friday. At or around 4:50 p.m. The contestants will be called on the air to congratulate them. Each winner will win one iPad or iPad Mini worth \$299.00 or \$399.00. The Station is not responsible for how the iPad or iPad Mini come after being shipped or mailed. The Station is not responsible for any warranty on all devices received. The Stations is not responsible for any telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call. The Station is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches. Due to delays in the K104-FM online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air Promotions.

2. Eligibility Restrictions:

- The Promotion is open to all persons who are 16 years of age or older and who reside in the immediate 12 counties in the Dallas/Fort Worth metropolitan area. The Station will also delete any entry knowingly received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

- The Station, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of the Station's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
