

Terms & Conditions

Afrozons Dubai SoundOff 2021 Trip Winners

In addition, all Giveaway recipient must have a valid passport or travel document, must have no travel restrictions and the winner must travel to Chicago-Illinois, Atlanta-Georgia, Dallas-Texas, or Los Angeles-California at their own expense to board the international flight to Dubai.
